

CONSTITUTION of the SWEETWATER BAPTIST ASSOCIATION, INC.

(adopted by Messengers at 189th Annual Meeting, October 21, 2019)

PREAMBLE

We declare and establish this constitution to preserve and secure the principles of our faith, and to govern the Association in an orderly manner. This constitution will help preserve the liberties of each individual church.

NAME

The body shall be known as Sweetwater Baptist Association, Inc. located in Madisonville, Tennessee.

PURPOSE

The purpose of this Association shall be to empower, encourage and equip the churches of the Sweetwater Baptist Association, Inc. to strategically reach the lost for Christ locally, as well as across the world, through cooperating together with the churches of the Sweetwater Baptist Association, Inc., Tennessee Baptist Mission Board and Southern Baptist Convention.

OBJECTIVES

- To promote a kindred spirit, foster Christian fellowship and committed cooperation in shared ministry among the affiliated churches.
- To uphold the doctrines and principles of our Baptist Faith and encourage our churches to be loyal to these principles.
- To promote mission giving to the Association and Southern Baptist entities.
- To provide local and international mission opportunities for churches.
- To provide training for all areas of Christian ministry.
- To aid and assist member churches and pastors.
- To be available to pastors and churches to assist with conflict resolution, if requested.
- To support future decisions made by the Executive Board or the Messengers to the Associational Annual Meeting.

STATEMENT OF FAITH

The Holy Bible is the inspired word of God and is the basis for any statement of faith. This Association relies on the Bible for instruction on all matters concerning ordinances, ministries, activities, membership and employment. The Holy Bible is the sole guidance for faith and practice and all activities are to be consistent with, and not contrary to, the teaching of scripture. As an additional means of applying scripture to daily living and governing of the body, this Association adheres to the *Articles of Faith* listed in the *Baptist Faith and Message* as adopted by the Southern Baptist Convention, June 14, 2000.

RELATIONSHIPS

The government of the *Sweetwater Baptist Association, Inc.* is vested in the member churches that compose it. The Sweetwater Baptist Association, Inc. will cooperate with and support the Tennessee Baptist Mission Board and the Southern Baptist Convention, as long as said entities are in agreement with the statement of faith for Sweetwater Baptist Association, Inc.

This Constitution was approved and adopted by the Sweetwater Baptist Association, Inc. on October 21, 2019.

THE BY-LAWS OF SWEETWATER BAPTIST ASSOCIATION, INC.

I. MEMBERSHIP

SECTION 1: GENERAL

The Association is a self-governing fellowship of member churches sharing a common faith and mission. The churches of the Association are autonomous. The fellowship of churches involves oneness, shared life and support; a common faith, grounded in harmony in faith and practice.

The Association shall be composed of churches affiliated and cooperative with the Tennessee Baptist Mission Board and Southern Baptist Convention, and which are in conformity with the purposes of the Association in their doctrine, polity and practice, and which have given evidence of support to the Sweetwater Baptist Association, Inc., the Tennessee Baptist Mission Board, and the Southern Baptist Convention.

SECTION 2: NEW CHURCH ADMISSIONS

Churches desiring to affiliate with the Association shall make a written petition to the Mission Committee for consideration. They must also submit a copy of the record where the church has voted to request membership. The following information must be included in the petition:

- A brief history of the organization of the church/mission
- Evidence of cooperation or intention of cooperation with the Sweetwater Baptist Association, Inc., Tennessee Baptist Mission Board and the Southern Baptist Convention.
- A written statement of the Articles of Faith and Covenant that the church has adopted.
- A brief history of the achievements of the church to date of petition. (*For example*: has the church acquired property; has the church constructed a building; how often do they have preaching services at the church, etc.)
- A listing of current church leadership with contact information at time of petitioning.

SECTION 3: PROCEDURE FOR NEW CHURCH ADMISSIONS

The Associational Missions Committee shall investigate the petitioning church and based upon their investigation, can choose to make a recommendation during business session to place said church under watch care. If accepted, the petitioning church will be placed under the watch care of the Association for a minimum of six (6) months. A majority vote is required to place said church under watch care.

During this time the accepted church will be entitled to all rights and privileges of the Association, except that of voting. At the conclusion of the watch care, the Missions Committee will again meet with the church to give opportunity for any questions or suggestions, by either the church or the Missions Committee.

At the conclusion of the watch care period, the Missions Committee can choose to recommend during business session to accept the petitioning church. A two-thirds majority vote during the business session will be necessary

for admission into the Association. If admitted, a church shall be considered a regular standing congregation with full privileges at the ensuing Associational Meetings.

If the recommendations of the Missions Committee concerning the said church do not receive a two-thirds majority vote of the voting business members present, it shall be automatically referred back to the Missions Committee.

II. CHURCH MEMBERSHIP REQUIREMENTS

SECTION 1: ANNUAL CHURCH REPORTS

It shall be the duty and the responsibility of the churches to correspond with the Association by annual church report/letter each year on the forms furnished to the churches for that purpose. This report/letter is expected to be in the Associational office by the due date.

SECTION 2: FINANCES

It is understood that membership in the Association involves financial obligation to support its ministries with regular, proportionate gift. Churches affiliated with the Association must annually share in the financial support of the work of the Association.

SECTION 3: FAILURE TO MEET REQUIREMENTS

A church holding membership in the Association must participate financially in the work of the Association and must file an annual report of its work to the Association. If a church fails to meet either of these two requirements, then the Association shall initiate the following process in an effort to redeem such a church back into active participation and fellowship:

- 1) The first year a church fails to meet a requirement, the Director of Missions and/or Missions Committee will make a personal contact with the church and/or pastor for the purpose of seeking to discover what the difficulty may be and to encourage the church to participate.
- 2) If a church fails to meet a requirement for two (2) consecutive years, that church will not be recognized as a participating church during business session(s). Said church will not be permitted to have voting privileges. Executive Board members and Messengers will not be recognized. Once both church membership requirements are met, voting privileges will be reinstated and Executive Board members and Messengers will be recognized.

III. AUTHORITY

The Association shall have no ecclesiastical jurisdiction over churches' internal affairs. The Association is available to advise, give counsel and propose measures.

The Association shall have power to withdraw fellowship from any church which departs from the doctrines and practices adhered to by this Constitution, and set forth in *Baptist Faith and Message* as adopted by the Southern Baptist Convention, June 14, 2000.

Any questions concerning fellowship with the churches shall be referred in writing to the Missions Committee. After consideration, the Missions Committee shall submit their recommendations to the business sessions.

IV. SWEETWATER BAPTIST ASSOCIATION OFFICE POLICIES, PROCEDURES & PERSONNEL HANDBOOK (aka SBA Handbook)

SECTION 1: GENERAL

The Sweetwater Baptist Association, Inc., Office Policies, Procedures & Personnel Handbook (aka SBA Handbook) will be used as a guideline for office operations and procedures. The SBA Handbook is not part of the By-laws of the Sweetwater Baptist Association, Inc. The SBA Handbook defines job descriptions for staff, department directors and non-standing committees. Non-standing committees and departments may be added or removed as the needs of the Association dictates and do not require any Constitutional or Bylaw amendment. The SBA Handbook also includes building and property usage guidelines. The SBA Handbook may be updated or revised, as

needed. Updates or revisions may be made to the SBA Handbook by the appropriate Committees and/or Officers of the Sweetwater Baptist Association, Inc.

V. MEETINGS

SECTION 1: EXECUTIVE BOARD

The Associational Executive Board shall meet annually as specified by the Associational Calendar of Events. The Executive Board shall be responsible to hear and transact business presented on behalf of the Association.

A. QUORUM

A quorum consists of those eligible Executive Board Members who are in attendance at the meeting that has been property called.

B. EXECUTIVE BOARD MEMBERS

Executive Board Members shall consist of:

- Associational Staff, Associational Officers and Associational Council,
- Pastor/Interim Pastor or in the event the church has no Pastor or Interim Pastor, the Chairman of the Deacon becomes the first Executive Board Member from each church,
- One elected Executive Board Member from each church.

Names of Executive Board members from each church must be submitted to the Sweetwater Baptist Association, Inc. in order for a list of Executive Board Members to be compiled. Each member church is permitted to have two (2) voting Executive Board members. One member must be the Pastor or Interim Pastor. In the event the church has no Pastor or Interim Pastor, the Chairman of the Deacon becomes the first Executive Board Member. The second Executive Board member shall be one (1) elected member from the participating church. All Executive Board Members must be a member of the church they represent. All Executive Board Members must be age 18 or older.

The Executive Board list shall include Associational Staff, Associational Officers and Associational Council. Members of the Associational Staff, Associational Officers and Associational Council will be considered automatic Executive Board Members with voting privileges, and do not have to be duly elected by their participating church(es). The Associational Staff will not be considered as the one duly elected Executive Board Member to represent their participating church(es).

Visitors will be welcome to attend the business session, but only registered Executive Board members will be allowed to participate in the business session.

SECTION 2: ANNUAL MEETING

The Associational Messengers shall meet annually as specified by the Associational Calendar of Events. The Messengers of the Associational Annual Meeting shall be responsible to hear and transact business presented on behalf of the Association.

A. QUORUM

A quorum consists of those eligible Messengers who are in attendance at the meeting that has been properly called.

B. MESSENGERS TO ANNUAL MEETING

Messengers shall consist of:

- Associational Staff, Associational Officers and Associational Council
- Pastor/Interim Pastor or in the event the church has no Pastor or Interim Pastor, the Chairman of the Deacon becomes the first Messenger from each church; and shall be first of seven (7) Messengers,
- Six elected Messengers from each church for a total of seven (7) Messengers.

Each member church will be entitled to seven (7) Messengers. Messengers, other than the Pastor, shall be duly elected by their participating church, prior to the Annual Meeting of the Sweetwater Baptist Association, Inc. Names of Messengers must be submitted to Sweetwater Baptist Association, Inc. office in order for list of Messengers to be compiled.

The Messenger list shall include Associational Staff, Associational Officers and Associational Council. Members of the Associational Staff, Associational Officers and Associational Council will be considered automatic Messengers to the Annual Meeting and do not have to be duly elected by their participating church(es). The Associational staff will not be considered as one of the duly elected Messengers to represent their participating church(es).

Messenger registration card(s) or form(s) will be made available to the church clerks of the Sweetwater Baptist Association, Inc. to submit names of Messengers. Messenger registration(s) must be returned, prior to the Annual Meeting to the Sweetwater Baptist Association, Inc. office, by the due date as set by the Associational Calendar of Events.

During Annual Meeting registration, each Messenger will be presented a Messenger name-tag by the Associational Clerk or Assistant Clerk. The Messenger will be required to wear the name-tag during the Annual Meeting in order to participate in business session. All Messengers must be a member of the church they represent. All Messengers must be age 18 or older.

Visitors will be welcome to attend any and all of the Annual Meeting Sessions, but only registered Messengers will be allowed to participate in the business session.

SECTION 3: SPECIAL MEETING

The Executive Board may be called into a special session at a time and place set by the Director of Missions, or Missions Committee Chairman provided churches are notified at least ten (10) days before the special meeting. The notification should state the time, place and purpose of the meeting. All special meetings may deal only with the stated purpose(s) of the meeting.

SECTION 4: ANNUAL CORPORATE MEETING

The Annual Meeting business session(s) may be considered and also constitute the Annual Meeting of the Corporation.

A. QUORUM

The quorum consists of those eligible members who are in attendance at the business meeting, provided it is a regular business meeting.

SECTION 5: VOTING RIGHTS OF MEMBER CHURCHES

Registered member(s) present of member church(es) of good standing and having met all requirements (per Item II. *Church Membership Requirements*, Section 3. *Failure to Meet Requirements*) are entitled to vote in all elections and on all questions.

SECTION 6: VOTE

The type of vote used shall be determined by the Moderator.

SECTION 7: RULES OF BUSINESS AND DECORUM

- Robert's Rules of Order (Revised) shall be used as authority in all deliberations of the Association.
- Moderator shall call to order each session at the appointed time.
- Any member wishing to address the Association shall rise in place and address the Moderator.
- Moderator shall decide points of order, subject to an appeal from his decision to the Association. He shall have the preference to speak to or explain when an appeal is taken from this decision.

VI. STAFF OF THE ASSOCIATION

SECTION 1: GENERAL

The Sweetwater Baptist Association, Inc. will be served by employed staff, as deemed necessary. All employed staff of the Sweetwater Baptist Association, Inc. are voting members during business sessions.

SECTION 2: DIRECTOR OF MISSIONS

- Job description provided in SBA Handbook
- When necessary, position shall be filled by recommendation of the Missions Committee, with a two-thirds majority vote, during business session.
- Employment shall be for an indefinite period of time.

SECTION 3: ADMINISTRATIVE ASSISTANT

- Job description provided in SBA Handbook
- Employed for an indefinite period of time upon the recommendation of the Director of Missions, with the approval of the Personnel Committee. No vote of the Association is needed for employment.

SECTION 4: MINISTRY ASSISTANT

- Job description provided in SBA Handbook
- Employed for an indefinite period of time upon the recommendation of the Director of Missions, with the approval of the Personnel Committee. No vote of the Association is needed for employment.

VII. OFFICERS OF THE ASSOCIATION

SECTION 1: GENERAL

The Sweetwater Baptist Association, Inc. will be served by officers, as deemed necessary. All officers of the Sweetwater Baptist Association, Inc. are voting members during business sessions.

SECTION 2: DIRECTOR OF MISSIONS

- Shall work with all officers of the Association and its organizations and the committees in giving counsel, guidance and oversight to every phase of the Associational work.
- Shall serve as ex-officio member with all committees of the Association.

SECTION 3: MODERATOR

- After fulfilling term as Vice-Moderator, will automatically assume the office of Moderator for the coming year.
- In the event Vice-Moderator cannot serve to assume office as Moderator, he shall be nominated by and elected by a majority vote of Messengers at Associational Annual meeting.
- Cannot serve more than (1) year in succession.
- Shall preside at all regular or special called meetings of the Association.
- Shall serve as ex-officio member of all committees.
- Will appoint two (2) members of the Committee on Nominations during the Annual Meeting.
- Will serve as member of the Committee on Nominations with voting privileges.

SECTION 4: VICE MODERATOR

- Shall be nominated by and elected by a majority vote of Messengers at Associational Annual meeting.
- Shall preside in the absence of or at the request of the Moderator at Executive Board Meeting or Associational Annual Meeting.
- Will automatically assume the office of Moderator for the remainder of the term, in the event the Moderator cannot complete his term.
- At the end of 1 year term as Vice Moderator, will automatically assume the office of Moderator for the following year.

SECTION 5: CLERK/ASSISTANT CLERK:

- Office filled by Administrative Assistant or Ministry Assistant as defined in SBA Handbook.
- Shall be responsible for keeping accurate minutes of all business meetings.
- Shall compile reports from committees and churches in the annual Minutes of Sweetwater Baptist
 Association.
- Shall hold all records as property of the Association.
- Shall return records in possession at time of resignation or change of officer to Association.

SECTION 6: TREASURER/ASSISTANT TREASURER:

- Office filled by Administrative Assistant or Ministry Assistant as defined in SBA Handbook.
- Shall be responsible for keeping accurate accounts of all receipts and disbursements of all monies handled by the Association.
- Shall prepare a written report for business meetings of Association.
- Shall print Associational budget in the associational newsletter prior to the Annual Meeting.
- Ex-officio member of the Finance Committee.
- Shall hold all records as property of the Association.
- Shall return records in possession at time of resignation or change of officer to Association.

VIII. CORPORATE OFFICERS

SECTION 1: GENERAL

The officers of the corporation are the officers who can act on behalf of the corporation. These officers have no power other than those express powers given to them by the corporation.

The term of the corporate officers shall run for the period of one year, coinciding with the Associational year or until their successors are chosen and elected. The President and Secretary are voting officers of the Sweetwater Baptist Association, Inc. during business sessions.

SECTION 2: PRESIDENT

The office of President is held by the Director of Missions position. The President shall have general and active management of the Corporation, and shall see that all orders and resolutions are carried into effect.

SECTION 3: SECRETARY

The office of Secretary is held by the Treasurer position. The Secretary shall attend all meetings of the corporation and shall be responsible for preparing the minutes of such meetings.

IX. COMMITTEES

SECTION 1: GENERAL

Committees are responsible for planning and promoting the work and ministries of the Sweetwater Baptist Association, Inc. The Association will be served by five (5) standing Committees. Additional Committees may be established according to the needs of the Association. Committees, other than standing Committees, will be defined in the SBA Handbook.

All committees shall be under Associational control; all committee members/officers must be elected by vote of Messengers at Annual Meeting. Committees are required to report as needed to the Association. All committee members must be members of participating churches. All committee members must be 18 years of age or older.

SECTION 2. GENERAL PROVISIONS FOR STANDING COMMITTEES:

- Each committee shall be composed of at least three (3) and no more than five (5) members, all of which are in good standing of an affiliated church of the Sweetwater Baptist Association, Inc.
- Committee members shall assume their elected duties on adjournment of the current Annual Meeting of the Association.

- Members who have fulfilled their term shall not be eligible for re-election to the same Committee until out of such office for one Associational year.
- Individuals are not eligible to serve on more than two committees simultaneously, except those who serve on standing committees by virtue of their office. This restriction shall not prevent one from serving on special committees.
- Members of Committees shall be on a rotating basis. Upon completion of serving term, the Senior Committee Member(s) will move off, and a new member(s) is added.
- The new Chairman of a Committee shall be the one next in seniority on the Committee. Committee members may deem it necessary to request a change in chairmanship.
- Committees will meet as necessary.
- Committees shall report as needed to the Association through the Chairman or through an appointed Committee representative. Reports will be made during business sessions.

X. STANDING COMMITTEES

SECTION 1: GENERAL

The Sweetwater Baptist Association, Inc. will be served by five (5) standing Committees.

SECTION 2. COMMITTEE ON NOMINATIONS

- Shall be responsible for bringing recommendations for all committee members of the Sweetwater Baptist Association, Inc.
- Shall be responsible for bringing recommendations for all Department Directors of the Sweetwater Baptist Association, Inc.
- Two (2) members of the Committee on Nominations will be appointed by the Moderator during the Annual Meeting. They will replace two (2) senior members of the Committee on Nominations who will rotate off the Committee on Nominations each year.
- The incoming Moderator will serve as a member of the Committee on Nominations with voting privileges.

SECTION 3. BUDGET/FINANCE COMMITTEE:

• Shall prepare and present the proposed annual operating budget.

SECTION 4. MISSIONS COMMITTEE

- Shall be responsible for promotion, development and guidance of the mission work of the Association.
- Shall assist the Director of Missions in working with the churches in mission related and church related issues
- Will be responsible to serve as a Search Committee and present a candidate for Director of Missions, as needed.

SECTION 5. PERSONNEL COMMITTEE

- Will be responsible for working with the Director of Missions to employ all office staff and personnel.
- Will have the responsibility of giving assistance to office personnel employed by the Association.
- Is not responsible for hiring Director of Missions.

SECTION 6. TRUSTEES

- Will hold in trust the property of the Association.
- Will have the actual care of the real and personal property, but shall have no power to buy, sell, mortgage, lease or transfer any property without a specific vote of the Association authorizing such action.

- Will execute, acknowledge and deliver any and all leases, agreements, deeds, mortgages, deeds of trust and any and all other papers, instruments or other documents, but only after authorized to do so.
- A majority of Trustees must sign all legal papers in behalf of the Association, and such signing must be witnessed by the Director of Missions.

XI. DEPARTMENT DIRECTORS

SECTION 1: GENERAL

Department directors shall work with the Director of Missions to promote and direct ministry opportunities of respective departments to plan meetings to train and equip the churches. Associational Department Directors are defined in the *SBA Handbook*. Associational Department Directors may be added or removed as needed.

XII. ASSOCIATIONAL COUNCIL

SECTION 1: GENERAL

The Associational Council of the Sweetwater Baptist Association, Inc. shall be composed of Associational Staff, Associational Committee Chairmen and Associational Department Directors. The Associational Council shall work with the Director of Missions to plan and promote Associational training, events, mission and activities.

XIII. USE OF PROPERTIES

SECTION 1: GENERAL

The intended use of buildings or property of the Sweetwater Baptist Association, Inc. is solely for Associational administration and ministries. Buildings or property cannot be used as meeting space by individuals, community or civic organizations except for member churches as defined in the *SBA Handbook*. Properties cannot be used for any purpose that is in violation of biblical doctrine. Further use of building and property is defined in the *SBA Handbook*.

XIV. FISCAL YEAR

SECTION 1: GENERAL

The fiscal year shall run concurrently with the Associational year which begins on <u>October 1 and ends September</u> 30.

XV. AMENDMENT(S)

SECTION 1: GENERAL

Proposed amendment(s) to the *Constitution and By-laws* of the Sweetwater Baptist Association, Inc. will be presented by the Constitution Committee. Notification of proposed amendments to the *Constitution or By-Laws* must be presented to the churches in writing 30 days in advance of the business session and voted on at ensuing business session of the Association. Amendments to the *Constitution or By-laws* shall be made by two-thirds (2/3) vote of all members present who are entitled to vote during business session of the Association.

Proposed amendment(s) to the *Constitution or By-laws*, presented from the floor during a business session, will be referred to the Constitution Committee for consideration.

Amendment(s) must be added to and kept with the official copy of the *Constitution and By-laws* at the time they are passed.

These By-laws were approved and adopted by the Sweetwater Baptist Association, Inc. on October 21, 2019.

195th Annual Session of the SWEETWATER BAPTIST ASSOCIATION Celebrating 195 years, 1830-2025

Theme: He Sends Us Forth

Business Session: New Macedonia Baptist Church, Philadelphia October 20, 2025, Monday evening, 6:30 p.m.

- 1. The 2025 SBA Associational Council Report video presentation of the ministries of the Sweetwater Baptist Association was presented.
- 2. Director of Missions, Tony Rutherford shared a word of thanks to Pastor Mitch Isbill and New Macedonia Baptist Church, Philadelphia for hosting the 195th Annual Meeting of the Sweetwater Baptist Association. Tennessee Baptist Mission Board and TBC Entities in attendance were welcomed. Kelly Campbell from the Tennessee Baptist Children's Home was recognized and welcomed. The Director of Missions also presented greetings to all attending and the opening prayer.
- 3. A video message from Dr. Randy Davis, Executive Director-Treasurer, Tennessee Baptist Mission Board was presented.
- 4. Steve Pearson, Harvest Field 4 Team Leader, Tennessee Baptist Mission Board, shared a word of greetings from the TBMB and presented a plaque to the Director of Missions for Golden Offering giving. 15 churches of the SBA provided gifts to the GSMO offering.
- 5. The *Memorial Report* was presented as a *PowerPoint* presentation of names of those that had passed away during the year. The *Annual Meeting* and *Minutes of the Sweetwater Baptist Association for 2025* were dedicated in memory of former pastors: Marvin "Bud" Millsaps and Jimmy David Hollinghead.
- 6. Pastor Mitch Isbill, New Macedonia Baptist Church shared a word of greetings, welcome and prayer.
- 7. The Director of Missions presented the "James Patton" gavel to Moderator, Jamie Johnson.
- 8. Moderator, Jamie Johnson, Member, Delano Baptist Church, shared a word of welcome, and that it was his privilege to call to order the 195th *Annual Meeting of the Sweetwater Baptist Association*.
- 9. Clerk, Becky Jones, moved that Messengers from the churches present constitute a quorum, and be duly seated to conduct the business of the 195th Annual Meeting of the Sweetwater Baptist Association. Second by Gabe Brannon, motion carried unanimously.
- 10. The Moderator thanked the Messengers for the prayers and the opportunity to serve as Vice-Moderator and Moderator, and to be part of the various Committees during the past years. The Moderator appointed Patrick Dalton, Notchey Creek Baptist Church and Dustin Atkins, Rocky Springs Baptist Church to serve on the *Committee on Nominations*.
- 11. After a brief transition of power from Moderator Jamie Johnson to Vice-Moderator Gabe Brannon, Pastor, Union McMinn Baptist Church, the Vice-Moderator presided over the remaining sessions for the evening.
- 12. The Moderator stated during the Election of Officers, that historically, the Vice-Moderator automatically moves into the Moderator position for the upcoming year for the Sweetwater Baptist Association. Thus, Gabe Brannon, Pastor of Union McMinn Baptist Church, would serve as Moderator for 2025-2026.
- 13. Bill Wilson nominated Rick Harris, Pastor South Madisonville Baptist Church, to serve as Vice-Moderator for the 2025-2026 Associational Year. With no further nominations, motion by Darrell Cardin, second by Richard Parker that nominations cease, and that Rick Harris be elected by acclamation. Motion carried, with no opposition.
- 14. Messengers were instructed by the Moderator that the Officers for 2025-2026 were Gabe Brannon, Moderator and Rick Harris, Vice-Moderator.
- 15. Committee on Nominations Chairman, Bill Wilson presented the *Committee on Nominations Report* for 2025-2026 and moved to adopt the report as printed in the *Messenger Handout* booklet. Motion carried, with no opposition.
- 16. Motion by Sheri Stephens to adopt the *Treasurer's Report* as presented; second by Shane Johnston. Motion carried, with no opposition.
- 17. Finance/Budget Committee Report was presented by Committee Member, Trey Ferguson. He reviewed the proposed budget changes as printed in the Messenger Handout and moved the adoption of the budget for 2025-2026. Motion carried, with no opposition.

- 18. Director of Missions, Tony Rutherford, shared 15th Annual *DOM Report* to the Messengers of the Association. He thanked the churches for their prayers and for welcoming him as he visited the family of churches. He shared his vision of *Looking Forward as (1) Individuals and Families; (2) The Church and (3) The Association.* He stated that his written report and statistical report were included in the *Messenger Handout*.
- 19. Motion by Tony Rutherford, second by Jonas Turpin to accept the *2026 Calendar of Activities for the Sweetwater Baptist Association* as printed in the 2025 *Messenger Handout* with any further changes or stipulations that might be needed in the future. Motion carried, with no opposition.
- 20. Motion by Tony Rutherford, second by Carroll Hamilton, to receive all reports of the ministries of the Sweetwater Baptist Association and Tennessee Baptist Mission Board to be included in the 2025 Book of Reports. Motion carried, with no opposition.
- 21. Motion by Tony Rutherford, second by Darrell Cardin that the 2025 Annual Meeting and 2025 Associational Minutes be dedicated in memory of former pastors Marvin "Bud" Millsaps and Jimmy Hollinghead.
- 22. The Director of Missions reported that the Sweetwater Baptist Association will be holding their 200 Bicentennial Celebration in 2030.
- 23. The Director of Missions presented a plaque for outstanding service and leadership to Moderator, Jamie Johnson.
- 24. The Moderator called for old business, and there was none.
- 25. The Moderator called for new business, and there was none.

This brief report highlights recommendations brought before the Executive Board this past year. A review of the previous Minutes, Director of Missions Semi-annual Report and Treasurer's Report are presented to the Executive Board, as well.

(The Executive Board Meeting for 2025 was held early in order to hear a report from visiting former Executive Director of the Guatemala Baptist Convention and Pastor, Otto Echeverria and his wife, Ruth from First Baptist Church, Coatepeque, Guatemala.

March 11, 2025

Vice-Moderator, Jamie Johnson did an outstanding job in leading the Business Session, and Moderator, David Lane shared the message for the evening. The Memorial Report included Dedication of the 2024 Minutes of the Association in memory of former pastors: Joseph Ronnie Moore, Wayne Caloway Nichols, Ronnie C. Watson and Charles Gale Miller. The *2025 Annual Meeting* is scheduled for October 20, at New Macedonia Baptist Church, Sweetwater and it has been confirmed that the *2026 Annual Meeting* will be hosted by Rocky Springs Baptist Church on October 19, 2026.

BIBLICAL STUDIES CLASS: The fall session for the *2024 Biblical Studies Class* was *The Armor of God: Being Ready for Battle* and led by Dr. Donald L. Parker, retired Director of Missions.

She offers Divorce, Addiction and Grief Recovery, as well as Individual Counseling for depression, anxiety, fear, anger, worry, and negative emotions. CHRISTMAS: The 2024 *Senior Adult Christmas Show* was held on December 9th at Union McMinn Baptist Church with special guests, The Lore Family. This southern gospel singing family was also be featured at the *Pastor and Wife Christmas Banquet* on the same evening.

The 2025 Senior Adult Christmas Show will be held on December 8th and will be hosted by Union-McMinn Baptist Church. The 2025 Pastor and Wives Christmas Banquet will also be held on the same evening. Special guests for the evening will be The Shirah Brothers.

The 2026 Senior Adult Christmas Show will be held on December 7 at Union McMinn Baptist Church. The 2026 Pastor & Wives Christmas Banquet will also be hosted by Union McMinn Baptist Church, and held on December 7th . Special guests have been confirmed and will be The Perry's.

CLERK TRAINING: A *Church Clerk Training* was offered on September 25 and 26, 2025 with topics that included writing Minutes of Business Meetings, Church Membership and Completing ACP Reports. We had 8 churches represented in attendance. The Seminar was led by Rebecca Jones. The *2026 Church Clerk Training* is planned for August 25th.

DISASTER RELIEF: Disaster has occurred across our world, country, and even hit our East Tennessee area numerous times during the past year. Floods, tornados, and to our amazement, an earthquake was reported in our area this year! Yet our churches have constantly responded to the needs of others.

Many of our churches have continued to provide prayers, support and ongoing relief for the people of Ukraine. Our Resident Interpreter, Svitlana Self continues to be available to share the needs of churches, pastors, families and friends that remain in Ukraine. She can also assist with the distribution of monetary gifts to assist those that remain in the Ukraine. Thank you to the many churches for ministering to those deeply affected and severely impacted by the crisis in Ukraine. Thank you for always being generous supporters of missions around our world.

In late September, 2024, many areas of upper East Tennessee and North Carolina were destroyed by the leftovers of Hurricane Helene. Continued rain and wind brought devastating damage to these areas with the worst flood in history. Many of our local churches responded with volunteers and crews for feeding teams, heavy equipment teams, and much needed supplies. A tractor/trail load of supplies and the disaster relief trailer were filled by our churches and delivered to the affected areas. Many families, homes and communities suffered great loss through damaging floods. Lives were impacted. Yet our churches responded to the victims by providing much needed necessities and financial assistance totaling over \$106,000. Thank you for being part of missions across our country. (A special news article appeared in the Baptist & Reflector, September 24 issue, Hurricane Helene: One Year Later, regarding some of the work of the churches of the Sweetwater Baptist Association.)

The SBA disaster relief trailer was used by Westside Baptist Church to take relief supplies to Morgan County. Westside still has the Associational disaster relief trailer loaded with goods to distribute in the event of another disaster.

In June 2025 a thunderstorm spun into a tornado causing damage to property in a two-mile path in a rural neighborhood in the Monroe/Loudon County community. No fatalities were reported but several people were injured. Thank you to those that responded to meet needs here at home.

In July 2025 a devastating flood hit when the banks of the Guadalupe River in Texas rose more than 20 feet in less than three hours, killing over 100 and leaving hundreds missing. This included campers and counselors at an all-girls camp located along the river. Our churches provided funds through the Tennessee Baptist Mission Board, Disaster Relief for the victims and families of those that lost lives.

Our prayers continue to be with the many that have been affected by tragedies.

EVANGELISM: Notchey Creek Baptist Church in conjunction with the Sweetwater Baptist Association hosted the *2025 East Tennessee Ministry Summit* on Saturday, February 24th. Special speakers for the morning session included: Dr. Roc Collins, Dr. Phil Hoskins and Dr. Randy Davis. The evening session featured preaching by Dr. Roc Collins, Strategic Objectives Director, Tennessee Baptist Mission Board. Special music for both sessions was presented by Notchey Creek Praise Teams.

The 2026 East Tennessee Ministry Summit is being planned for Saturday, February 28th and will be held at Notchey Creek Baptist Church. Tentative plans call for the Morning Session to begin at 8:30 a.m. on Saturday, February 28th. Special guest preachers will be Dr. Jim Henry, Rev. Allan Taylor, and Dr. Roc Collins. Pastor, preachers, teachers and all

church leaders are especially encouraged to attend the morning preaching/training conference. The special guest speaker for the *Evening Session*. *Evangelism Rally* will be Dr. Jim Henry. Everyone is invited to attend both sessions.

Churches were encouraged to do outreach and evangelism throughout the year, but were asked to pick at least one day in the month of August to do a community outreach or an evangelism project. This was promoted as *AWESOME AUGUST*! This was an excellent opportunity for our 75 churches to project to promote a planned ministry event to reach others for Christ in their community.

EXECUTIVE BOARD: Members of the Executive Board met at Cedar Fork Baptist Church on March 11th for the regular *Semi-Annual Business Meeting of the Sweetwater Baptist Association*, with 19 churches represented and 41 in attendance. (See *Clerk's Report* for additional information.) The date of this meeting was changed from the date on the *Associational Calendar of Events*. This change in date was made in order to coincide with the visit of Pastor Otto Echeverria and to allow his attendance and update of Guatemala missions at the Executive Board Meeting.

The 2026 Semi-Annual Meeting will be held at Howard's Chapel Baptist Church on April 13.

GUATEMALA: In January, 2025 a small vision team traveled to Guatemala to view areas of work and review current ministries. This team prepared for a group to return in June from Brittsville Baptist Church (CrossNet Association) in Georgetown, TN where Pastor Jake Evans currently serves.

From that January vision team, a new mission group was formed with volunteers from Brittsville Baptist Church, and this short-term mission team traveled to Guatemala to share the Gospel, June 6-13. Our Director of Missions was asked to serve as the group leader for the ten (10) volunteers and Pastor Otto Echeverria was asked to serve as the mobilizer in Guatemala for this team. The team worked with Pastor Hamid Gutierrez in the Sela Community with the Sela Community Fellowship Church. Ministries included food bag give aways, school visits with candy bag give aways, visit to a care center, home visits, Vacation Bible School, sports evangelism and preaching services. This team reported 4 professions of salvation.

On June 17-24, eleven (11) mission volunteers from Poplar Bluff Baptist Church traveled to Guatemala to share in partnership missions. This team continued to work with Pastor Antonio at Iglesia Bautista Macedonia, Aldea La Union, Macedonia Baptist Church, La Union. Ministry included: women's workshop, ladies Bible study; men's Bible study; Vacation Bible School; door-to-door witnessing; evangelism/crusade/revival; medical clinic; sports evangelism; food give-away and for the first time, a youth Bible study. This team reported salvations in 7 home visits and 38 in VBS.

Then on June 24-July 1, two (2) teams of mission volunteers from Bethlehem Baptist Church and Birchfield (Chilhowee Association) returned to Guatemala to continue on-going work with Pastor Hugo Barrios at the Jesús es El Camino Baptist Church El Cañal, Pastor Hugo Barrios. In addition, teams worked with Cristo La Unica Esperanza, La Palmita, Baptist Mission and Las Mercedes, Pastor Fred Aguilar, Cordero de Dios Baptist Church. Since this was such a large group, movement of the team was fluid, once there. Ministry for the youth and adults included: women's workshop on prayer; ladies Bible study at all locations; men's Bible study; Vacation Bible School; door-to-door witnessing; visit schools; evangelism/crusade/revival and medical clinics.

Guatemala mission projects are being planned for 2026. The tentative dates are June 5-12, June 16-23, and June 23-June 30.

HAITI: In 2010, the Sweetwater Baptist Association of Churches partnered with Pastor Gaetan Alcegaire and the Yahve Shamma Orphanage in Haiti after a devastating earthquake. Even though that partnership officially ended in 2016, we have continued to correspond with Pastor Gaetan. When we learned of a great need for food and support for the 43 children currently in the care at the orphanage, the churches of the Association were asked to be part of a ministry to support the children in Haiti by receiving a special love offering for the Haiti orphanage. At that time, over \$9500.00 was collected from the churches, and funds were distributed to the orphanage on a monthly basis during 2025. We ask that you continue to pray for Pastor Gaetan and the children at the Yahve Shamma Orphanage.

LOCAL/OUTREACH/MISSIONS: The Sweetwater Baptist Association helped to facilitate *Winter Giveaways* with backpack, hat, and toboggan giveaways at Citico and Howard's Chapel in December of 2024.

The Association also assisted numerous churches in the development and mailing of *Every Door Direct Mail for* special events. Upon requests, we are always available to assist with announcements for church news for various revivals, Vacation Bible Schools and new pastor announcements for communities.

As the Association Office was made aware of requests, churches were encouraged to provide handicap ramps for those in need. Congregations responded in a great way by providing assistance in their communities.

All churches were encouraged to participate in the *Awesome August initiative* and report their ministry outreach during the month of August.

The Sweetwater Baptist Association in conjunction with the Notchey Creek Baptist Church, Sequoyah High School FCA and Tellico Plains High School FCA sponsored an *On the Mound* event 5th Quarter on Friday, August 29th at Sequoyah High School. Guest Speaker was Kirby Connell, former UT pitcher, and special music was provided by the Notchey Creek Baptist Church Praise Teams. Many decision cards were collected at the conclusion of the event. Results included prayer requests for family, life struggles, and questions about salvation.

Other miscellaneous items included the following. The Director of Missions will participate in leading a tour group to Greece in November, 2025. The Missions Committee worked with the Budget/Finance Committee in the transfer of funds to a second bank in order to assure all funds for the Sweetwater Baptist Association were FDIC insured. The Director of Missions was encouraged by the Missions Committee to take time to tend to his wife during her illness. In 2030, the Sweetwater Baptist Association, Family of Churches will celebrate 200 years of ministry, 1830-2030. The Associational Staff will work to select a Committee to assist them in the planning and encouraging all to participate in the *Bicentennial Celebration*, 2030.

LOWER CHILHOWEE: In August, the Sweetwater Baptist Association completed and fulfilled their process in the reactivation of Worship Services at Lower Chilhowee Baptist Church. It was a blessing to assist the congregation with the reopening of the Worship Services and Pastor Joey Bivens was called to serve as Pastor. The Church elected a Trustee and Church Treasurer. They are moving forward to resume all financial and governing responsibilities. A statement from Lower Chilhowee Baptist Church is to be provided to the Sweetwater Baptist Association affirming the church has accepted all duties and responsibilities of the church. Our prayers continue to be with this congregation.

MEDIA: The Associational Media Center has approximately 60 Bible Studies available for churches to borrow. There are a wide range of studies, including children and youth studies, ladies, men and couples' studies, Deacon studies and more. The studies are available for Sunday School classes, Small Groups, Ladies Studies, Youth Studies, etc. Upon request, additional videos and studies can be added as funds are available.

An electric folder was purchased to assist in folding bulletins, letters, posters, programs, and flyers. Computers, printers and office equipment continue to be efficient and updated to the current operating systems.

Four (4) additional chairs were purchased for the downstairs conference room. A small cordless vacuum was purchased. Improvements for all areas of the office have been made, as needed.

The ministry and disaster relief trailers continue to be well kept, and in good repair. Locks were fixed on the door and windows of the ministry trailer. No known repairs are currently needed at the disaster relief building, as it continues to be well maintained.

Tony agreed that the project could wait until next summer and it would save the Association several thousand dollars.

We are so thankful to the many volunteers that work together to keep the Associational Office building, equipment and trailers in good repair in order to have a great place for the churches of the Association to do ministry.

The Baptist and Reflector (B&R) is 190 years old this year, making it one of the 25 oldest, continuously published newspapers in the United States. Since 1835, the B&R has produced news features, and editorials that tell the story of Tennessee Baptists while also informing their biblical worldview.

The B&R is an award-winning newspaper frequently recognized by the Baptist Communicators Association for excellence in journalism, and is produced 26 times a year, reaching nearly 40,000 readers.

Additionally, the B&R website (BaptistandReflector.org) has grown steadily since it was introduced in late 2015, with more than 350,000 page views. The weekly e-newsletter has 21,000 subscribers and highlights breaking news, top stories from the print edition and news that appears in the online edition. The Baptist and Reflector continues to growth in our social media platforms such as Facebook, Instagram and X.

Over the past year, the B&R has extensively reported Tennessee Baptist Disaster Relief's efforts to help the people of East Tennessee recover from the devastating effects of Hurricane Helene. The paper has also offered frequent updates on Tennessee Baptist Mission Board's restructuring to bring it into alignment with the ministries Tennessee Baptists said they wanted to pursue through the Acts 2:17 Initiative. There was also a steady stream of great news stories focused on Tennessee Baptists and their churches ministering to their communities and sharing the Good News of Jesus Christ.

The B&R staff monitors, reports, and distributes the most pertinent stories related to the Southern Baptist Convention and cultural trends that could affect Tennessee Baptists.

The paper continually seeks new subscribers, either through individual subscriptions or through a multiple-subscription church rate plan. Every church needs a subscription and every church's leadership team, like pastors, ministers, deacons, Sunday School teachers, etc., need to stay informed about Baptist life in Tennessee.

2025 BAPTIST MEMORIAL HEALTH CARE SYSTEM

Baptist Memorial Health Care began as a 150-bed hospital in downtown Memphis in 1912. It was formed by the Southern Baptist Conventions of Tennessee, Mississippi and Arkansas because they recognized a tremendous need for a health care facility in this part of the country. The hospital eventually grew to become the largest private hospital in the world.

The Baptist Memorial Health Care system was created in 1981 to provide an integrated health care delivery system offering a full continuum of care to communities throughout the Mid-South. Today, a total of 24 hospitals in Arkansas, Tennessee and Mississippi; an 1,100-member physician group; and dozens of other entities are affiliated with Baptist.

Baptist Memorial Health Care's staff chaplains are a part of the health care team. Patients, family members and employees know they can ask for a chaplain at any time to augment our health care with spiritual or emotional care.

For the past eight years, Baptist's Pastoral Care Department has hosted The Rev. Jimmy Terry Preaching Series. The series, named in memory of a beloved member of Baptist's Board of Trustees and the founder of Tabernacle Baptist Church in Clarksville, Tennessee, welcomes a speaker each month to deliver an evangelical message from Baptist's flagship hospital. Video recordings of each event are posted on our Facebook page. They have been viewed more than 182,000 times and have reached 124,000 people in the past year.

Baptist Memorial Health Care received state approval to build a new community hospital in Fayette County. The facility will serve West Tennessee along the I-40 corridor between Arlington and Jackson, near BlueOval City, Ford's automotive manufacturing ecosystem. The hospital will include eight emergency rooms, eight acute care inpatient beds, outpatient imaging and lab services.

The Centers for Medicare and Medicaid Services awarded Baptist Carroll County, Baptist Tipton and Baptist Union City four stars (out of five) for quality. The ratings are based on 46 quality measurements from five categories: mortality, safety of care, readmission, patient experience, and timely and effective care.

Baptist Carroll County and Baptist Union City earned "A" Leapfrog Hospital Safety Grades in fall 2024 and spring 2025. Baptist Carroll County has earned five consecutive "A" grades, and Baptist Union City earned four consecutive "A" grades.

Several Baptist Memorial Hospitals earned Tennessee Hospital Association Zero Harm Awards for their infection prevention achievements. Baptist Carroll County and Baptist Tipton were two of only eight hospitals in the state to be recognized for zero harm events in four categories. THA also recognized Baptist Collierville, Baptist Women's Hospital, Baptist Memphis and Baptist Union City for not having infections in specific departments.

2025 TENNESSEE BAPTIST ADULT HOMES, INC.

Report to Associations, 2025 Mark Anderson, President/Treasurer

Tennessee Baptist Adult Homes now has a ministry in west Tennessee!! In March of this year, we moved our first residents into the first four duplex apartments at the new Baptist Village Humboldt! The apartments were filled within the first month of opening and there are others who would move in if we had more. We are so excited that this ministry is up and going. You may recall that there was the possibility that we might have to liquidate the Humboldt project due to the financial strains of our group home ministry. God has provided! It is our belief He will continue to do so. As funds allow, we will build more duplexes at Humboldt. When the entire Baptist Village Humboldt project is completed, there will be 10 duplexes serving 20 financially needy retired pastors and missionaries.

Regarding the financial issues mentioned above, we have downsized our group home ministry by closing one of the homes and reducing our resident capacity from 55 to 47. The downsizing has resulted in cost savings of around \$200,000. Our increased Father's Day Offering in 2024 coupled with the generous allocation increase or Cooperative Program funds (about \$117,000) are even more examples of God's provision! What an exciting time for the ministry of TBAH. We believe that 4 homes with a capacity of 47 is the right size for this ministry. We fell to as few as 43 residents earlier this year, but the current census is 45. I am so glad our homes are here for the families who have loved and cared for their family members and are no longer able to provide that care.

It is our hope and belief that this downsizing has made us "right sized" and that there will not be need for further downsizing. Our Father's Day Offering is one way, and our best way, to eliminate further cuts to our ministry. As of July 24th, receipts through the 2025 Father's Day Offering are about \$20,000 ahead of last year. You may recall that last year we set a record of \$547,000! This year's goal is \$575,000. If we can stay \$20,000 ahead of last year's giving, then we are knocking on the door of reaching our goal for a second year in a row. Again, exciting times.

Tennessee Baptist Children's Homes has been welcoming children in hard places with the love of Christ for 134 years! Because of the faithfulness of churches, businesses and individuals who have a heart for children and families who are struggling, we have been able to serve over 237 children and their families over the past year. Thank you for your prayers, for your service, and for sharing your financial resources with TBCH. Our ministry operates without the use of government funds. We have chosen to rely on God's provision through His people to supply the resources necessary to meet the needs of the children and families we serve.

TBCH serves children through two programs. Our **Foster Care** program allows us to place children who are in the state's custody into homes where Jesus is loved and served and where children will have this godly influence in their lives for however long they reside in that home. Our foster care team and volunteers span from Memphis to Kingsport. The other program for providing gospel centered care is our **Residential Care** program. Our campuses in Brentwood, Chattanooga and Millington are all in the process of exciting changes related to our Firm Foundations Project. We are currently in construction mode on each of our three campuses to provide individual bedrooms and baths for each resident. Because of what many of our children have experienced or been exposed to, this need becomes more apparent as each year passes.

TBCH is making sacrifices to bring this "Firm Foundations Project" vision into reality. We are reducing the size of our campuses without reducing the number of children we serve. The liquidation of selected properties will help us complete Phase One of the Firm Foundations Project on each campus. While liquidated property is helping us put our plans into action we are still in great need of your financial assistance. Thank you to those of you whose church gives faithfully to the Cooperative Program and also makes a direct gift to TBCH through the Mother's Day Offering or through your annual missions offerings!

- 237 children served in the past year
- 19 adoptions in the last fiscal year and 14 so far this year
- 24 professions of faith in the last fiscal year and 6 so far this year- Praise the Lord!
- 70 foster homes statewide as of the writing of this report
- 127 children in care as of the writing of this report

The Tennessee Baptist Foundation has been serving TN Baptist with excellence since 1938. The assets under management of the Foundation have grown from \$6,577 to \$213 million during that time. God continues to bless this ministry, and we are pleased to make our report to the associations as to highlights for the fiscal year 2024-25 thus far.

The Foundation is pleased to offer the following services to Tennessee Baptists:

- Faith-based estate planning seminars for churches and ministries
- Working with individuals, helping them develop distinctively Christian personal estate plans (wills)
- ♦ Assisting individuals in their establishment of various Charitable Trusts
- ♦ Serving as Trustee of trusts and funds committed to its care
- Providing investment services to Tennessee Baptist churches, associations and institutions
- Helping churches establish Legacy Ministries and create Endowment Funds
- Providing grants for qualifying new ministries and projects

Highlights of the Foundation's stewardship thus far for this fiscal year include (as of June 30, 2025):

ANNUAL REPORT

Tennessee Woman's Missionary Union (TN WMU) encourages and equips churches and individuals to engage in missions learning and involvement that enables them to fulfill the Great Commission. This report shares information about some of the state events, ministries, and initiatives that have taken place.

Christian Job Corps (CJC) is a ministry of WMU that seeks to help men and women break the cycle of poverty through job and life skill classes, Bible study, and mentoring. There are 16 Tennessee CJC sites in 14 locations. In their 2025 annual ministry reports, these sites reported 784 participants in their various programs, nine decisions for Christ, and 417 volunteers serving 13,717 volunteer hours.

TNWMU's missionary care ministries are supported through funds from the Missions for Life Fund and the Golden Offering for Tennessee Missions (GOTM).

- Missionary Parents Fellowship (MPF): On September 28, 2024, 13 parents of International Mission Board (IMB)
 missionaries gathered via Zoom for a time offellowship, information, prayer, and encouragement. TN WMU supports the
 Tennessee MPF by maintaining its database, distributing communication/promotion materials, and helping to
 coordinate and host the annual state retreat. The 2024 retreat was canceled due to flooding in Tennessee and was
 rescheduled as a Zoom meeting.
- Encourage Collegiate MKs: Each year TN WMU assigns a Missionary Kid (MK) who attends college in Tennessee to every association so churches can encourage them. Thirteen MKs were assigned to associations for the 2024-2025 school year.
- Former Missionary Fellowships: Former missionaries in West, Middle, and East TN gather several times each year for fellowship, connection, and encouragement. TN WMU provides funds for meals during these gatherings.
- Christmas Gifts: In December 2024, TN WMU sent gifts to missionary kids and retired missionaries. A \$150 gift was sent to 13 MKs whose parents serve with IMB and are from Tennessee, and a \$50 gift was sent to 69 retired IMB missionaries born in Tennessee.
- MK Re-Entry Retreat: Six missionary kids from Tennessee received travel assistance funds to attend the MK Re-Entry Retreat, hosted by Virginia WMU and the IMB, from July 28 to August 2, 2025.
- Missionary Homes in Mt. Juliet: Tennessee Baptist Mission Board has two missionary homes in Mt. Juliet that provide
 much-needed rest for missionaries on stateside assignment: the TN WMU Missionary House (Mary's House) and the
 Missions Mobilization Center (MMC) Missions House. TN WMU takes care of reservations and hosts the missionary
 families for both houses. Donated gift cards are used to stock pantry staples and other household items.

As part of the prayer advocacy partnership with Denver, TN WMU sent a mission team of six women to Denver from October 3-7, 2024. The team met with nine church planters and prayed for them, their ministries, families, and the communities around the churches. TN WMU has sent nine teams to serve in Denver over the past eight years, meeting with more than 30 church planters to pray and serve their communities.

The 2024 Connection was held at Tennessee Tech University's Baptist Collegiate Ministry on September 13-15, 2024, where 132 youth girls and leaders representing 15 churches attended. The event featured Bible study leader Leslie Hudson and 1MB missionary speaker Angela Stoda.

RA Camp-o-Ree was held on October 18 - 20, 2024, at Linden Valley Baptist Conference Center with over 400 boys, leaders, and personnel in attendance. Boys participated in a multitude of activities, challenges, and crafts while enjoying the great outdoors, meeting missionaries, and attending two action-packed worship services. This missions camping event for boys in grades 1- 12 is hosted by Mid-South Royal Ambassadors and TN WMU.

Over 60 people attended the WMU Gathering at Summit on Sunday, November 10, at Northside Baptist Church, Murfreesboro. TN WMU, Concord Baptist Association WMU, and Northside Baptist Church partnered together to host this time of fellowship and inspiration.

The 2025 Missions Get-Together was held at First Baptist Church, Dickson, on April 4-5, with a total attendance of 512 people representing over 130 churches. Participants attended four general sessions and five breakout sessions and connected with over 30 missions and ministry leaders. Participants donated over 9,000 items, \$60 in cash, and \$1,100 in gift cards for Pregnancy Resource Centers across the state through the event's ministry project. An additional \$13,005 was given through the event's missions offering, benefiting the Amy Hood Adoption Endowment (90%) and the TN WMU Tennessee N Touch Endowment (10%).

The 2025 TN WMU Annual Meeting occurred on April 5 during the Saturday morning general session of Missions Get-Together. The meeting included highlights of the work of TN WMU and the election of 2025-2026 state officers and new Executive Board Members.

TN WMU awarded \$36,600 in scholarships to 39 students attending graduate school, seminary, and undergraduate school in Tennessee for the 2025 - 2026 school year. These scholarships are funded through endowments, invested funds, and the GOTM.

In 2025, TN WMU collaborated with churches, associations, and other ministries to host over 15 adult and youth Mental Health First Aid (MHFA) training events across the state, as part of our emphasis on addressing the critical issue of mental health. MHFA is a skills-based training that teaches participants to identify, understand, and respond to mental health and substance use challenges.

The 2024-2025 Tennessee Missions Emphasis theme was "All Things Tennessee," with a GOTM goal of\$2,700,000. As of July 25, 2025, the total amount was \$2,462,461. The offering year goes from September 1 to August 31.

2025 CARSON-NEWMAN UNIVERSITY

ASSOCIATIONAL REPORT

Since Carson-Newman's founding in 1851, Tennessee Baptists have been instrumental in its creation, maintenance and growth. Your partnership and support enable us as Christian educators to help our students reach their full potential as educated citizens and worldwide servant-leaders. Highlights of this past year include:

We welcomed students from 44 states and 55 countries for the 2024-25 academic year.

- At the start of the 2024-25 academic year, we launched the public phase of the largest comprehensive campaign in our history. Entitled "Legacy," the \$73 million phase of this initiative includes new academic programs, campus buildings and student recreation.
- C-N is already enjoying fruits grown out of the Legacy campaign. Last fall, we held two ribbon cuttings in one day, opening the 110,000 square-foot West Campus Commons residence hall and a new student Recreation Park, featuring: softball field, soccer pitch, and basketball, beach volleyball, pickleball courts. A new Child Development Lab opens this fall on the western perimeter of campus.
- The campaign has opened doors to new academic offering: Master of Divinity, MBA in Entrepreneurial Leadership,
 Master of Accountancy and Business in Analytics. Degree programs in Homeland Security and Emergency
 Management, Artificial Intelligence in Business, and Hospitality and Tourism Management launched this fall. A
 Doctor of Nursing Anesthesia Practice launches Jan. 2026. Each offering is rigorous while being taught with a biblical
 worldview.
- Last fall we celebrated with 31 members of our Eagles football team who made public professions of faith by being baptized in Mossy Creek. This is the most we have ever had and demonstrates how the Spirit is moving on campus in mighty ways.
- For 2024-25, chapel on Tuesday and Thursday had an average attendance of 415 students (a 6% increase from the previous year.)
- C-N's Serve Day last year saw over 600 students take part in outreach at some 40 project sites across multiple counties. Students also packed 11,000 meals to be distributed to help feed those in need.
 In 2024, Appalachian Ministries of the Smokies (AMOS) celebrated 40 years of ministry. When the year had concluded, AMOS' Ministry Center had served 1,358 families and 3,339 individuals. The Home Repair Ministry completed 30 projects across four counties, while Samaritan House served 32 homeless families and provided 8,595 meals to those in need.
- Last year, C-N students shared the love of Jesus Christ through Spring Break mission trips to Los Angeles, Hawaii, Ecuador, Honduras, Southeast Asia, Alaska, Denver and Barcelona.
- This year U.S. News & World Report championed Carson-Newman's online programs. Carson-Newman and Vanderbilt University were the state's top private institutions in the Online Master's in Nursing Program category. In the Online Master's in Education Program category, only the University of Memphis was ranked higher than Carson-Newman in Tennessee. C-N was also named a "Christian College of Distinction" by Texas-based organization Colleges of Distinction.

2025 THE KING'S ACADEMY

Since 1880, Harrison-Chilhowee Baptist Academy has been serving East Tennessee and the world as a distinctively Christian school. For more than 30 years, Tennessee Baptists' accredited Christian boarding and day school has operated under the name of The King's Academy. Located in Seymour, TN, at the foothills of the Great Smoky Mountains, TKA continues to reach students locally and globally.

This past summer has been a season of transition, but God's provision and faithfulness have been evident at every step. Even through uncertainty, we have seen His hand clearly at work—raising up new leaders, opening doors for ministry, and reinforcing the truth that this school belongs to Him.

Here are some of the ways God has been at work at TKA this year:

- **Residence Life Program**: We anticipate serving 31 international students representing 17 countries. This diversity continues to enrich our Christ-centered, global community.
- Shen Science Center: After years of prayer and planning, construction has begun on the Shen Science Center. This facility will strengthen our academic program, particularly for students seeking STEM careers, and expand our reach among international families.
- Spiritual Life: Chapel Theme "Known": This year's chapel focus is built on John 10:14—"I am the good shepherd; I know my sheep and my sheep know me." In the fall, students will study the Gospel of John. In the spring, the life of David. Our goal is for every student to know they are seen, known, and loved by God.
- Education Freedom Scholarship: Over 100 students applied and enrolled at TKA through Tennessee's EFS program, reflecting both the need and the effectiveness of our outreach to local families.
- **Library Renovation**: The school library received a full refresh with new carpet, paint, and a new Middle School Writing Lab. This space now better serves our growing student body.
- Campus Security Enhancements: All campus security cameras are in the process of being upgraded, and a new DVR system was installed to provide higher-quality footage. Student safety remains a priority.
- **Dual Enrollment Partnership**: TKA launched a new partnership with Carson-Newman University offering on-campus dual enrollment classes in College Algebra and Composition. This allows students to earn college credit in a Christ-centered learning environment with trusted faculty.
- **Elementary Enrollment Growth**: Several elementary grades now have waiting pools, reflecting strong interest from local families and continued enrollment momentum.
- **Projected Enrollment**: Based on current applications, enrollment is on pace to surpass our budgeted goal of 415 students, potentially reaching 430 this fall.

Through every challenge, God has reminded us that He is in control. We step into this school year with peace, not because we know the future, but because we trust the One who does.

Thank you for your continued support, encouragement, and prayers. We are honored to be part of the Tennessee Baptist family and remain committed to raising up students who live out their faith with courage and purpose.

2025 UNION UNIVERSITY

Samuel W. "Dub" Oliver, Ph.D., President, Union University

At Union University, our vital partnership with Tennessee Baptists continues to shape our mission. As we reflect on the past year, we are reminded that our work is anchored in these core values: **Excellence-Driven**, **Christ-Centered**, **People-Focused**, and **Future-Directed**.

Consistent with the Tennessee Baptist Mission Board's strategic priorities — **strengthening and multiplying Gospel leaders, evangelistic disciples, and healthy churches** — Union has worked intentionally to connect students with ministry opportunities:

- The first TBMB ministry pipeline internship has been developed by Josh Franks in partnership with Union and area pastors. Beginning in the spring of 2026, students will serve in local churches, earn academic credit, and receive support from the TBMB, which plans to replicate this model across the state.
- At the request of TBMB, Union developed and taught its first class on church planting this past spring. Twenty-one students participated.
- Union hosted its second ministry fair this year, connecting students with local churches and ministries for internships and summer service.

Selected Highlights from the Past Year

- In March, we opened and dedicated **The Ethos Forum**, a new academic facility for the McAfee School of Business and our computer science and engineering programs.
- Our comprehensive fundraising campaign, "Union 200: Tradition. Truth. Transformation." is progressing, with just over \$52 million given and pledged toward the \$80 million goal. Our next major project is a new chapel at the heart of campus a space for worship, training, and sending out Gospel leaders.
- In April, our trustees adopted a university Framework for Biblical Anthropology, developed by Union faculty to
 articulate a biblical view of humanity. The full version is available at www.uu.edu/about/framework-for-biblical-anthropology.cfm.
- In March, hundreds of volunteers at Union participated in a six-day public reading of the entire Bible under Miller Tower as part of the 2025 Spring Bible Conference. As Isaiah 40:8 reminds us: "The grass withers, the flower fades, but the word of our God will stand forever."
- Union women's basketball coach Mark Campbell, who leads with Christ-centered excellence, was inducted into the Women's Basketball Hall of Fame in June.
